BY-LAW # 19-2016

**Special Services Proposal for the Collection & Transport of Garbage/
Recycling Materials**

BEING a by-law to establish a rate for providing for the collection and transportation of garbage or recyclable materials as a special service to the former Village of Cartwright and the South-West Rock Lake Resort Area for the years 2016-2018 inclusive;

WHEREAS Section 312 of The Municipal Act (hereinafter known as the "Act") of Manitoba, provides in part as follows:

312 If approved by by-law, a municipality may provide, as a special service to all or part of the municipality, the following:
the collection and transportation of waste or recyclable materials;

AND WHEREAS subsection 320(1) of the Act provides as follows:

320(1) Subject to subsections (2) to (6) and subsection 321(4), a council may by By-Law approve the local improvement or special service as set out in the proposal; and authorize the municipality to impose taxes as set out in the proposal or proposal.

AND WHEREAS the Council of Cartwright-Roblin Municipality has prepared Special Service proposal No. 2-2016 to establish per parcel rates for the collection and transportation of garbage and recycling within the former Village of Cartwright and the South-West Rock Lake Resort Area as a special service pursuant to Part 10 of the Act;

AND WHEREAS the requirements as prescribed in section 318, 319, and 320 of the Act have been complied with;

NOW THEREFORE the Council of Cartwright-Roblin Municipality in open council assembled enacts as follows:

That pursuant to Section 320(1) of the Act, Cartwright-Roblin Municipality approves Special Services proposal No. 2-2016 attached hereby as Schedule "A" and Schedule "C".

That Cartwright-Roblin Municipality levies an annual special service tax upon properties within the municipality as hereby attached in Schedule "B" and Schedule "D".

For
**Collection and Transportation of Garbage or Recyclable Materials from
the former Village of Cartwright
to Cartwright-Roblin Municipality Waste Transfer Station**

(Pursuant to section 314 of the Municipal Act)

(A) Description of the Proposed Special Service

Cartwright-Roblin Municipality wishes to establish a special service proposal for the **Collection of Garbage or Recyclable Materials** from properties within the former Village of Cartwright. This special service proposal will apply to the years 2016-2018 inclusive and replaces by-law 305-2014 which expired at the end of 2015.

(B) Special Service area to be levied

The Special Service Area to be levied under this proposal will be all property (including taxable, Grant-In-Lieu and otherwise exempt property) within the former Village of Cartwright.

(C) Estimated cost of the Service

Cartwright-Roblin Municipality currently operates a manned Waste Transfer Site and Recycling Depot. Curbside pickup for garbage and recycling is provided to developed lots within the former Village of Cartwright. Basic beautification will be provided to vacant lots within the former Village of Cartwright i.e. collection and transportation of stray litter for absent or incapable owners of vacant lots.

The estimated cost of the service shall be the amount paid for collection and transportation of garbage and recyclable materials for 2016 including labour, equipment, and supplies necessary for collection and transportation of garbage or recyclable materials within the former Village of Cartwright to Cartwright-Roblin Municipality waste transfer station.

The rates for 2017 and 2018 include an adjustment based on the change in the Consumer Price Index (CPI) which is estimated to be approximately 3% per year; shortfall, if any, will be covered by the General Operating Fund.
(2015 tax: \$175.00)

(D) Method and Rate of Calculating the Proposed Special Services Tax

The method of calculating the annual Special Service Tax will be based on an amount per parcel. The rate is: a flat tax of \$5.00 for vacant lots and up to a maximum tax of \$226.50 (2016), \$263.70 (2017), \$271.66 (2018) on class 10 properties and up to a maximum tax of \$1941.00 (2016), \$1999.23 (2017) and \$2059.21 (2018) on class 20, 30, 40, 52 & 60 properties.

2016: (59 vacant lots @ \$5=\$295.00; 15 commercial properties (other than standard rate)= \$9131.00; 201 residential/other lots @ \$226.50=\$45,526.50; \$295.00+\$9,131.00+\$45,526.50=\$54,952.50)

REGARDING SPECIAL SERVICE PROPOSAL – BY-LAW # 19-2016

Collection and Transportation of Garbage or Recyclable Materials from the former Village of Cartwright to Cartwright-Roblin Municipality Waste Transfer Station

(NOTE: This special service proposal will apply to the years 2016-2018 inclusive and replaces by-law 305-2014 which expired at the end of 2015 and adds a special service tax to the Rock Lake resort area lots which have received curbside picked up in the past years funded via municipality's at large tax mill rate. Cartwright & Rock Lake each have separate tax rates for 2016 onward.)

The Council of Cartwright-Roblin Municipality has scheduled a public hearing at The Municipal Chambers, 485 Curwen Cartwright, Manitoba on the 28th day of April 2016 at 7:30 P.M. to present the following proposal:

- Special service proposal for collection and transportation of garbage or recyclable materials for the years 2016-2018 inclusive within the former Village of Cartwright.
- The special service area to be levied will be all property (Including Taxable, Grant-In-Lieu and Otherwise Exempt) within the former Village of Cartwright.
- The estimated cost of the service is \$54,952.50 for 2016.
- The proposed method of calculating the Special Services Tax will be levied per parcel with a flat tax of \$5.00 for vacant lots and up to a maximum tax of \$226.50 (2016), \$263.70 (2017), \$271.66 (2018) on class 10 (residential 1) properties and up to a maximum tax of \$1,941.00 (2016), \$1,999.23 (2017), \$2059.21 (2018) on class 20, 30, 40 & 60 properties.
- Shortfall, if any, will be covered by the General Operating Fund. (2015 tax rate: \$175.00)

A written objection may be filed with the Chief Administrative Officer, at 485 Curwen, Cartwright, Manitoba prior to the commencement of the hearing. At the hearing, Council will hear any potential taxpayer who wishes to make a presentation, ask questions or register an objection to the special service proposal.

All objections, written or verbal, must be filed prior to the adjournment of the hearing and must include the name, address and property description of the person filing the objection and the grounds of their objection.

A copy of the special service proposal is detailed on reverse.
